[15] Description of Product

The H38 product, Part No. 01059 is an Industrial Encoder, shaft position transmitter. This product is provided with a cast aluminium enclosure of explosion-proof design incorporating electrical components providing data for remote shaft position indication. The enclosure has provision for connection to threaded rigid metal conduit.

The ambient temperature range is -50°C to +90 °C.
